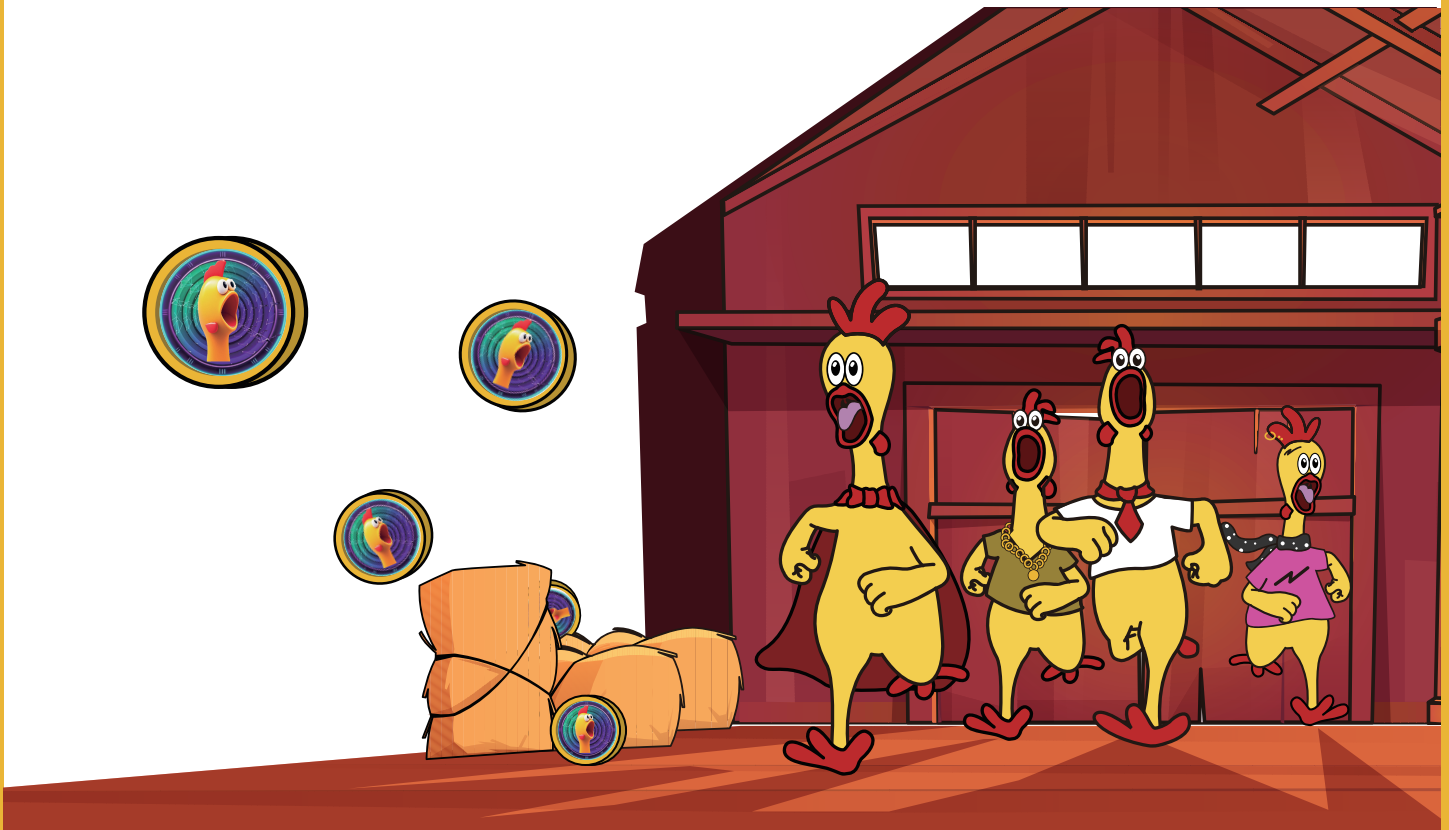
“Crazy Chicken” Introduction

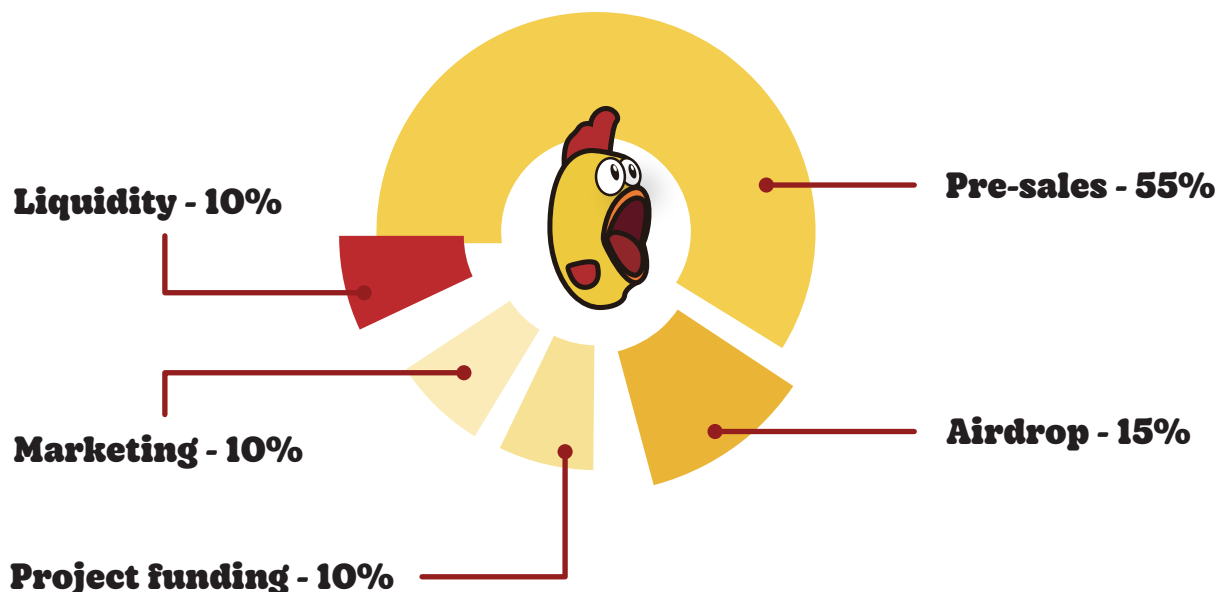


“Tokenomics”

Crazy Chicken will ensure that the token price does not fall below the price paid during the pre-sale, and the token price is fixed, providing a fair opportunity to all investors.

Since there is no volume allocated to the development team, the possibility of dumping is greatly reduced and instability factors after listing on the exchange are minimized.

“Roadmap”

The Crazy Chicken roadmap outlines a three-step plan for project growth and ecosystem development. In Step 1, the focus is on attracting venture capital investments, launching the Crazy Chicken Token through a presale, and officially introducing the token to the market. Step 2 emphasizes exchange integration by listing the token on major DEXs and CEXs such as Radium, MEXC, and Bitget, implementing a buy-back and burn mechanism to enhance token value, and expanding the team with skilled professionals for development and marketing. Finally, Step 3 aims to expand into the Solana ecosystem by launching NFTs and integrating with marketplaces, while also collaborating with global franchise brands to increase token adoption and utility.
